### Fall 2014 FFCOC Fly Tying Classes

The FFCOC is putting together fly tying classes that will enhance your fly fishing experiences. These clas-ses will be given at no cost to our club members. We are offering beginning, intermediate and advanced fly tying. The classes will be held one night a week and will run for six weeks. Our club is very happy to accept the offer of the REI/Tustin Store to host these classes in their Community Resource Room. The REI\Tustin store is located in the Tustin Ranch Market off the 5 Freeway at Jamboree, between Best Buy and Total Wine.

For the beginning class, we have limited number of fly tying vices, You will be able to take these vices home to practice your tying. The FFCOC will furnish all of the tying materials and hooks. All you will need to do is bring your basic fly tying tools. You will learn now to spot good/bad materials. Proportions, size and color will also be on the agenda. The Instructors will give you approximately three different fly patterns a night. Clas-ses will run from 6:00 pm to 8:30 pm. All of the classes will be held on a Thursday night. The dates for the fly tying classes are October 9, 16, 23 and 30 2014 as well as November 6 and 13, 2014

These classes are a fantastic opportunity to learn a new craft and /or elevate your tying skills. ## San Gabriel Mountains National Monument?

The San Gabriel Mountains are being considered for national monument status. A significant meeting with an overflow crowd in attendance was held August 26th in Baldwin Park to discuss this proposal.

Local environmental groups, city groups, biologists and cultural experts joined Rep. Judy Chu, D-Pasadena, and Los Angeles County Supervisor-elect Hilda Solis of La Puente in calling on Obama to take action. Efforts in this direction have been underway for years, motivated by the belief this status would bring money that could significantly protect the forest and improve recreational access.

Opponents are concerned that this change would affect access to drinking water. Apparently the San Gabriel mountains are a source of drinking water for one-third of LA County residents.

According to the San Gabriel Valley Tribune, Chu and Solis have been working towards this for more than 10 years as a way to bolster resources to the area which is the most used urban forest in the nation. They say the National Park Service does a better job managing recreation. The Forest Service might continue to responsibility for fire suppression.

It's believed that, if created, the new National Park would encompass about 600,000 acres, cutting a swath of current forest lands from Castaic to Mt. Baldy!

If this proposal comes to pass, my hope is that our local fisheries would be enhanced, littering and vandalism greatly reduced and the overall usage experience greatly improved.

Dear Ms. Burns and the Fly Fishers Club of Orange County,

Thank you for the honor of receiving the Fly Fishers Club of Orange County Marine Studies Scholarship. I appreciate your kind and generous offer of this scholarship and I am very honored that I have been selected to receive this award. This is a wonderful opportunity that you have provided for graduate students. I am very grateful and happy to have this help to further my education so that I can pass on what I have gained to others through environmental education and community outreach.

I graduated with a Bachelor's Degree in Zoology and Conservation from the University of Wisconsin-Madison. I started doing research on fish behavior and fisheries management as a junior in college. I specifically worked with smallmouth bass and walleye. After I graduated, I joined the United States Peace Corps and served in the Philippines as a Coastal Resource Management Technician. While there, I lived with a local family in a small coastal fishing town. I worked with the local fishing families and the local government to establish a local marine protected area, which was established about two years after I competed my service. In the Philippines I started working with local schools and students. I co-organized two ecology camps, one of which was specifically designed for girls and female adult mentors in different communities in the Philippines. These were incredible and moving experiences. The goal of the program was to introduce alternative fish conservation methods pass to local fishing communities, but I gained so much more and learned so much from the students, local leaders, and local families.

When I returned, I obtained a teaching credential from University of San Diego. After three years in San Diego, I moved to Ojai, California and taught Biology, Chemistry, and Environmental Science at a small boarding school in upper Ojai. The school is located on 500 acres of preserved land. My family and I still live on the campus, where my husband works full time as an assistant to the Dean of Students and I work part time as part of the residential staff.

I am fortunate to have the opportunity to return to school for a Master's degree to expand on my knowledge and understanding of ecology and natural resources. Last year I began the Master's degree Marine Biology program in the lab of Dr. Mark Steele. My research entails comparing connectivity of estuarine habitats from year to year and how it is affected by both natural and human processes. I am specifically looking at California killifish and longjaw mudsucker populations to determine if there is genetic transfer among populations. This will give an indication of the extent of estuarine habitat connectivity in southern California. I am doing my research in 8 estuaries and comparing the fish populations of these two species in them in order to contribute to appropriate management plans for these beautiful and essential natural environments.

This award will greatly help fund my master's degree education at California State University Northridge. I will be the first in my family to obtain an advanced degree. The scholarship award will help offset student loans and will help me balance school, work, and family life by decreasing financial needs. I am very excited to return to the field to do research and to improve my research, writing, and communication abilities. CSUN's Biology department has very strong program for teaching all of these aspects.

My goals for the future include going on to school for a PhD in wetland and watershed management. One of my objectives is to be involved in community outreach and organizing in order to improve our daily life practices so that our natural resources are sustained. I particularly enjoy working with schools and their science, sustainability, and outdoor education programs.

Again, thank you for the Fly Fishers Club of Orange County Marine Studies Scholarship. I am very honored to receive this award.
